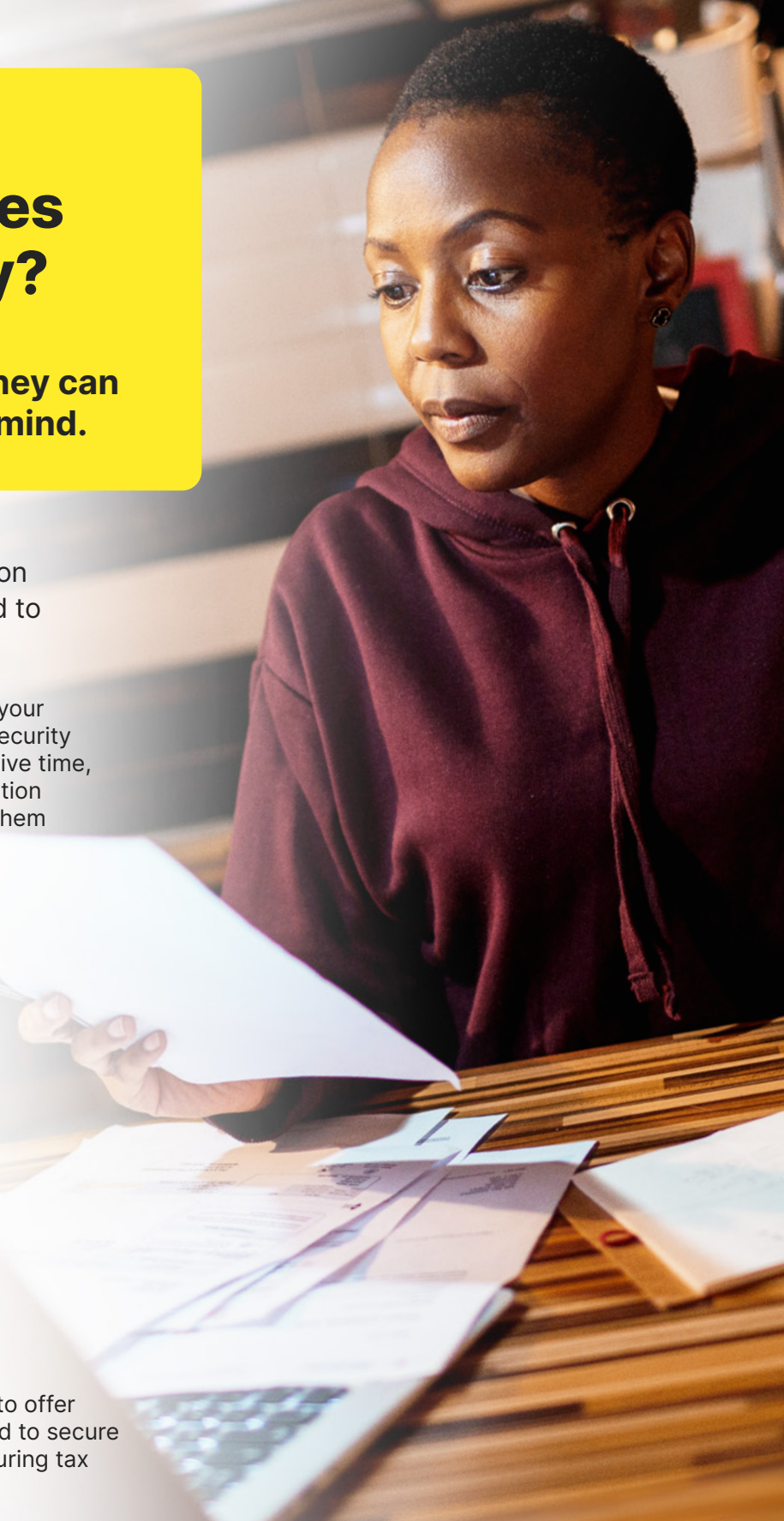


Fraudulent tax returns due to identity theft increased by 30% in 2023 compared to 2022, according to the IRS.

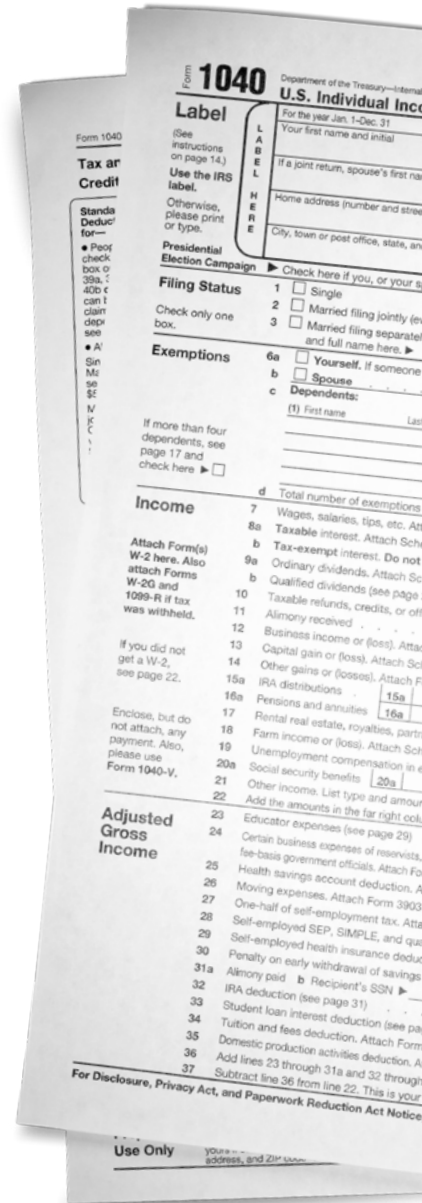
